



## Country Profile: Bhutan

Bhutan is a small, land-locked Himalayan country that completed its transition from an absolute monarchy to a constitutional monarchy in April 2008; the country is now led by a king and a democratically-elected government. The United States has consular, but not full diplomatic, relations with Bhutan. There is no US diplomatic or consular presence in Bhutan. Although no formal diplomatic relations exist between the United States and Bhutan, informal contact is maintained through the US Embassy in New Delhi, India. Updated information on travel and security in Bhutan may be obtained at the US Embassy in New Delhi, at any other US Consulate in India, the US Embassy in Kathmandu, Nepal, and the US Embassy in Bangkok, Thailand. US citizens living or traveling in Bhutan are encouraged to enroll through the <a href="#">Department of State's travel registration page</a>, noted above, or with the US Embassy in New Delhi to obtain updated information on travel and security within Bhutan. US citizens without Internet access may enroll directly with the US Embassy in New Delhi or missions mentioned below in person or via mail.
