



## Country Profile: Oman

The Sultanate of Oman, a land of great natural beauty on the southeast corner of the Arabian Peninsula, has a long and proud heritage. With a population of 2.6 million, Oman has seen rapid economic and social development in the past three decades. A monarchy governed by Sultan Qaboos bin Said, the country does not have political parties or a legislature, although a bicameral representative body (the lower house of which is directly elected) provides the government with advice and reviews draft legislation. While Oman is traditionally Islamic and Islam is the state religion, Omanis have for centuries lived with people of other faiths. Non-Muslims are free to worship at churches and temples built on land donated by the Sultan. The economy is largely dependent on the production and export of oil and natural gas, but is becoming increasingly more diversified. Excellent tourist facilities are available in the major cities of Muscat, Salalah, Sohar, and Nizwa and can increasingly be found elsewhere in the country.
